■ **OVERDUE DEBT POSITIONS OF THE TISCALI GROUP AS OF 28<sup>TH</sup> FEBRUARY 2014**

On 28<sup>th</sup> February 2014, overdue trade payables, net of payment plans negotiated with suppliers, amounted to EUR 35 million. There were also overdue tax debts for approximately EUR 11.4 million. There were no overdue debts towards the employees.

■ **POSSIBLE REACTION OF THE CREDITORS OF THE GROUP AT 28<sup>TH</sup> FEBRUARY 2014**

As of 28<sup>th</sup> February 2014, there were solicitations for payment only within the ordinary course of business. On that date the injunctions for payment received by the Company and not paid off because still in negotiation or opposition, amounted to a total of EUR 0.3 million.

There have been no suspensions of supply relationships which affect the course of business.

■ **RELATIONSHIPS WITH RELATED PARTIES OF TISCALI S.P.A. AND TISCALI GROUP**

The Tiscali Group holds relationships with related parties on terms deemed customary in the respective reference markets, taking into account the characteristics of goods and services provided.
