

Tiscali: update on the share repurchase programme

Cagliari, 29th April 2008

With reference to the plan for the repurchase of own shares, commenced, as communicated to the market, on 19th March 2008, Tiscali SpA announces the repurchase, on 18th April, of 2.600.000 own shares (0.45% of the share capital), at an average price per share of € 2.379, for a counter value of about € 6.2 millions.

The share buyback has been done pursuant to art. 2357 and subsequent articles of the Italian Civil Code and within the limits set by the shareholder's resolution.

Pursuant to art. 132 of Legislative Decree 58/98 and art. 144-*bis* of the Issuers' Regulation, the purchase took place on regulated markets pursuant to the markets' regulations. Moreover, the purchases have been done for daily volumes not exceeding 25% of the average daily volume of Tiscali shares negotiated in the month previous to the official communication of the plan, pursuant to art. 5 of CE regulation n. 2273/2003. Hereto attached the details of the purchase operations

Total number of treasury stock currently held by Tiscali is 2.600.000.
